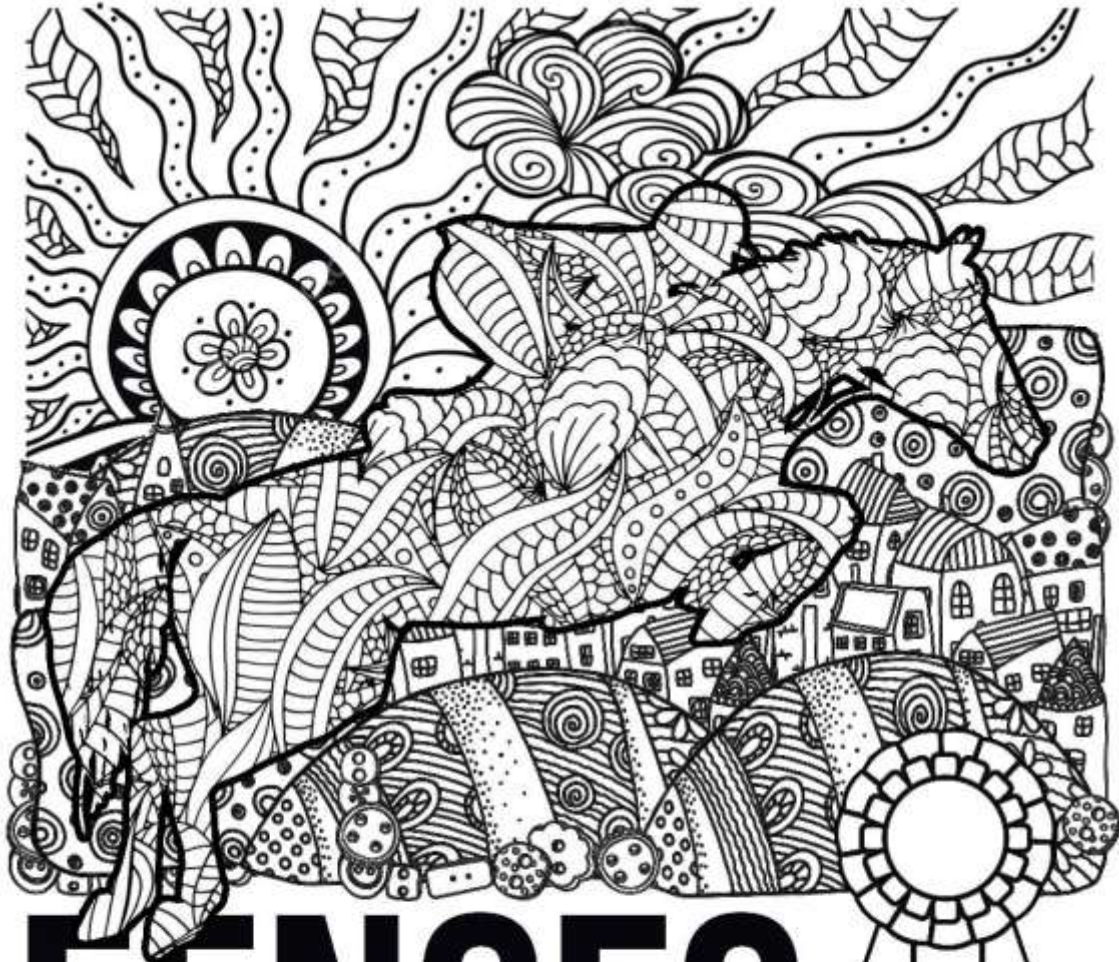

## Rules and Regulations

**Office/Medic Fee:** An office fee will be charged \$45 for each horse on the grounds both showing and non-showing, along with a \$20 medic fee per rider.

**Stabling Fees:** Stall Fees: \$80 for the entire weekend. Shavings must be purchased at the show: \$11 per bag. No horse may remain on the grounds overnight without renting a stall. Horses not stabled will be charged a \$50 grounds fee.

**Schooling Fee:** Non-showing horses will be charged a \$35 schooling fee in addition to any stall or grounds fee. Schooling will be available from Friday: 4:00pm – 7:00pm, and Saturday and Sunday until 30 min prior to the start of each ring.

**RV Hookups** will be available for \$45 per night.

**Entries:** Entries should be mailed to Holly Mortimer at 12619 Dringenberg Dr. Austin TX, 78729 or emailed to Giddyupngo@att.net. Checks should be made payable to Bee Cave Riding Center. Pre-registration requires no obligation, however, a \$35.00 late fee will be charged on entries received after 9:00 p.m. on Thursday before the show.

Equitation Classes – Entry fee \$20 per class

Medal Classes - \$30 per class

Opportunity Classes – Division entry fee: \$85 Individual classes: \$20/class. (Division entry fee includes 5 classes; warm-up class is \$20 additional to the division fee).

**Dress:** All riders must be properly attired and may be eliminated for improper dress. Hard hats must be worn by ALL riders when mounted. Coats should be worn in all divisions unless management announces otherwise.

**Changes:** The management reserves the right to change, cancel or combine classes, alter courses, and do all things necessary or appropriate to compensate for excessive or inadequate entries.

**Coggins:** Proof of a current (within the past year) Coggins test must be available

**Prizes:** Prize money to be deducted from bill. Trophy and 6 ribbons in each class.

**Add Backs:** Add back amount to be distrusted as follows:

30%-22%-16%-14%-10%-8%

**Judges Decisions** are final. Any act of discourtesy or disobedience to the judges or any show officials on the part of any owner, manager, trainer, coach, rider or groom shall disqualify the horse, and the owner shall forfeit all fees.

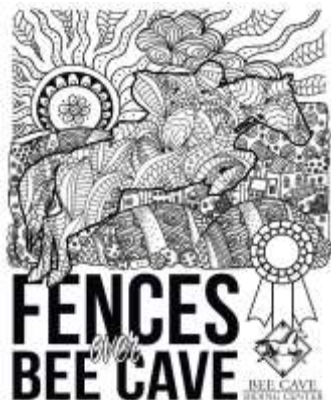
